

Complete this worksheet if you want to calculate partial claims for the following amounts on Form TD1NL, 2010 Newfoundland and Labrador Personal Tax Credits Return.

Do not give your completed worksheet to your employer or payer. Keep it for your records.

**Line 2 of Form TD1NL – Age amount**

If you will be 65 or older on December 31, 2010, and your estimated net income from all sources will be between \$27,400 and \$51,940, calculate your partial claim as follows:

**Line 6 of Form TD1NL – Spouse or common-law partner amount**

If your spouse's or common-law partner's estimated net income for the year (including the income earned before and during the marriage or common-law relationship) will be between \$641 and \$7,041, calculate your partial claim as follows:

Your spouse's or common-law partner's estimated net income for the year						2
Line 1 minus line 2						3
Enter this amount on line 6 of Form TD1NL.						

**Line 7 of Form TD1NL – Amount for an eligible dependant**

If your dependant's estimated net income for the year will be between \$641 and \$7,041, calculate your partial claim as follows:

Base amount			7,041		00	1
Your eligible dependant's estimated net income for the year						2
Line 1 minus line 2						3
Enter this amount on line 7 of Form TD1NL.						

**Line 8 of Form TD1NL – Caregiver amount**

If your dependant's estimated net income for the year will be between \$12,156 and \$14,643, calculate your partial claim as follows:

Base amount			14,643		00	1
Your dependant's estimated net income for the year						2
Line 1 minus line 2 (maximum \$2,487)	=					3
Enter the amount you claimed for this dependant on line 7 of Form TD1NL						4
Line 3 minus line 4						5
Enter this amount on line 8 of Form TD1NL.						

**Line 9 of Form TD1NL – Amount for infirm dependants age 18 or older**

You cannot claim this amount for a dependant for whom you claimed the caregiver amount on line 8 of Form TD1NL. If your dependant's estimated net income for the year will be between \$5,345 and \$7,833, calculate your partial claim as follows:

Your infirm dependant's estimated net income for the year						2
Line 1 minus line 2 (maximum \$2,488)	=					3
Enter the amount you claimed on line 7 of Form TD1NL for this dependant						4
Line 3 minus line 4						5
Enter this amount on line 9 of Form TD1NL.
